

WOMEN'S INTERNATIONAL BOWL

SILVER: GA 21.4 & below | **BRONZE:** GA 21.5 to 45.4 To be held between 4th March and 4th August 2025

CONDITIONS OF PLAY

- The Competition is 18 holes stroke (Nett) to be played by each club on its own course.
- A club may select up to three days between 4th March and 4th August 2025 to hold this competition.
- A single-entry fee of \$3.50 (inc. GST) entitles a competitor to return cards in one or all stipulated stroke rounds held within her club during the period stated for the competition.
- Players stay in the Division that they played their first-round in.
- Open to all financial playing female members of Golf WA affiliated clubs. Players may compete at all clubs of which they are a member.
- Ties at a club level should be decided using the Australian Countback System. Firstly, by scores obtained in the
 players' most recent round of which <u>all players eligible for the count back played in.</u> If this is not possible (as not
 all players qualifying scores were obtained in the same round), then by the most recent round played by all
 players who are eligible for the count back.
- The state level winners will be decided by calculating the Nett score against the par of the course played adjusting for any PCC for the round. In the event of a tie, there will be a count-back and score cards will be requested from necessary clubs. Clubs may purchase International Bowls badges from GolfWA at \$9 per badge (inc. GST) to award to the winner of each division.
- The International Bowl will be engraved with the state winner of Silver Division and the state winner of the Bronze Division. There is no state play-off for this competition.

COVID-19 Conditions for all GolfWA events

• All GolfWA conducted golf events will adhere to State and Federal Government requirements in place at the time of the event together with all policies/conditions in place at the host club venue. Note that requirements of the policy of a host club may exceed that of the State Government requirements and if so these parts of that host club's policy are binding.

• Where players are required to be vaccinated, they will need to show their vaccination status on registration. Note that any reference to a player also includes caddie, given a caddie is an extension of a player. In addition, these conditions may extend to spectators and visitors to a venue as directed by the WA Government and/or host club.

• GolfWA reminds players that if they are unwell, please stay at home. Additionally, if players are in an at-risk category, consider whether contesting an event is necessary. The ultimate playing of each event will be considered on a case-by-case basis depending on COVID-19-related circumstances leading up to and at the time of the event.

• At all times, the health and safety of players, event and host club personnel is GolfWA's main priority. Players must advise GolfWA or the tournament organiser as soon as possible if they are feeling unwell.

• Depending on the advice from the relevant government authority and GolfWA or the tournament organiser, a player may need to withdraw from the event. A player may be withdrawn from the event if for example, on the advice of the relevant government authority, a player must isolate because their playing partner had COVID-19-like symptoms.

Notes

• If there is a COVID outbreak at an event GolfWA will work with the relevant authorities to determine the safest action. Depending on the timing and severity of the outbreak, it may be that the event is cancelled, shortened, or a group of players are required to withdraw from the event.

• If circumstances change at an event and players incur costs in returning home (for example a player cannot return to their home state or requires hotel or other quarantine on arrival back to their home state because of COVID-19 requirements) GolfWA will not accept any responsibility for any costs incurred.
